

Board of Trustees Meeting Monday, July 29, 2024, via Zoom

- 1. Called to order at 5:30 p.m. by Bridget Asay (President). Present in person: Judy Walke, Tim Donovan, Donna Lasick, Heidi Parker, Sarah Seidman, Sarah Davis, Sarah Swift, Executive Director Dan Groberg. Absent: Jeff Dean, Tai Nixa Peterson, John Nelson, Dan Greene, Craig Durham, Edisa Revilla Muller.
- 2. The agenda was approved by consent. Walke moved and Swiftt seconded approval of the minutes of the 6-12-24 meeting with a correction to note that Swift was present for that meeting. Motion carried, with some abstentions due to absence.
- 3. Groberg reported on the meeting with the HP Cummings to review the construction contract. This is a fixed price contract of \$1,564,475 per requirements of FEMA. It does not include add-ons like the roof replacement, A/C, or skylight but does cover most other basement repairs and brings them up to code. The Dept. of Libraries' grant has not yet been announced. After discussion, including a request to have Groberg ask about warranties on the work, Donovan moved and Swift seconded a motion to authorize the ED to sign the contract with HP Cummings up to the specified amount. Motion carried.
- 4. Groberg noted that the library has \$20,000 in its Technology and Innovation Reserve Fund and suggested that \$4,635 be used to cover the costs of shifting to the Catamount Transition coalition. Seidman moved and Parker seconded a motion to use \$4,635 from the reserve fund for this transition. Motion carried.
- 5. There is no Board meeting scheduled for August but it is likely an Executive Committee meeting and a special Board meeting will be necessary. The next full Board meeting will be in person Sept. 18 at 5 pm in the Hayes Room. Groberg noted that the evening event with Amber McBride will be Sept. 26 at Christ Church with a paid reception afterward at the library.
- 6. The group adjourned at 6:10 p.m.
