

Executive Committee Meeting Friday, Nov. 15, 2024

The meeting was called to order at 2:07 pm via Teams by Judy Walke. Present: Jeff Dean, Donna Lasick, Sarah Seidman, Dan Groberg. President Bridget Asay was absent.

The agenda was approved by consent. Lasick moved and Dean seconded approval of the minutes of the 10-8-24 and 10-31-24 meetings. Motion carried.

ED Report: Groberg said he and Library Director Carolyn Picazio are working on a plan to align their work together more collaboratively. Due to delays in the arrival of glass, the building renovation will not be completed by the contract date in January but will be extended into February. Final repairs to the elevator will hopefully be completed in the coming weeks. Groberg is studying the pros and cons of air conditioner models for the a/c project. Efficiency Vermont rebates will likely pay \$16,000 or more for the air conditioning project, and he reminded the EC that we have raised \$40,000 and could receive up to an additional \$120,000 if all grant requests are approved.

Groberg will take a three-week unpaid leave of absence beginning Jan. 9 as his family deals with his wife's health issues. The EC agreed to hold an additional meeting in December and proposed a schedule for 2025 meetings as follows:

The group spent some time discussing the current strategic plan, which runs through 2025. They agreed that the next plan could be narrower in scope, retaining the goals/mission/values of the current plan. The EC will suggest at the November meeting that the full Board appoint a working group including staff, administrators and Board members, to outline the way forward.

Finance Chair Lasick will be absent for the November meeting but will have a written report. Board Development Chair Walke reviewed the three candidates to be nominated to the Board in November. Fundraising Committee Member Seidman said the fall appeal is about to launch.
